How Qatar Airways Ticket Cancellation Works in 2026

Qatar Airways checks fare conditions when you cancel to determine refund eligibility: refundable, partially refundable, or non-refundable.

- Refundable fares: full refund minus cancellation fees if unused; partially used tickets refunded for remaining value after flown segments. {{📞📞ask~expert}}
- Non-refundable fares: base fare and carrier surcharges (YQ/YR) are non-refundable; some taxes may still be returned.

Ticket validity for refunds: 12 months from issuance for unused tickets, and 12 months from first flight for partially used tickets.

Cancellation Timing and No-Show Rules

Timing impacts refund eligibility:

When Qatar Airways Will Not Refund Your Ticket

- Tickets used beyond turnaround point.
- Tickets flown out of sequence.
- Non-refundable fares where fare rules state no refund.
- Refund request after ticket validity expires (typically beyond 12 months).

Even if a non-refundable fare is later reissued as refundable, the original base fare and surcharges remain non-refundable; only the new portion follows flexible rules.

Special Circumstances and Legal Exceptions

- Local law may override airline policy, allowing refunds beyond 12 months.
- Passenger death: legal heirs can request refunds with proper documentation. **{{📞📞ask~expert}}**
